

OREO Dream for the Team: TERMS AND CONDITIONS

This document sets out the Terms and Conditions ("T&Cs") governing participation in the "Oreo Dream for the Team" activation ("Campaign"), an initiative by Mondelez India Foods Private Limited ("Mondelez"). By participating, you agree to be bound by these T&Cs.

1. INTRODUCTION

- 1.1 **Organizer:** Mondelez India Foods Private Limited, having its registered office at Unit No 2001, 20th Floor, Tower-3 Wing-C, One International Center Parel, Mumbai- 400 013.
- 1.2 **Campaign Partner:** Parv communications, E-109, Amar colony, Lajpat Nagar 4, New Delhi, 110024. or such other third party engaged by Mondelez for the execution of the Campaign (hereinafter, "Campaign Partner").
- 1.3 **Product:** This Campaign relates to the limited-period Oreo Dream for the Team pack activation.
- 1.4 **Voluntary Participation:** Participation is voluntary. You acknowledge that you satisfy all Campaign eligibility requirements.
- 1.5 **Definitions:**
 - i. **You or Your:** Any natural person participating in the Campaign.
 - ii. **We or Our or Mondelez:** Mondelez India Foods Private Limited.
 - iii. **Participant:** Any natural person fulfilling the eligibility criteria.
 - iv. **Prizes:** Refers to Grand Prize, Dreamer of the Match, Weekly Prize and Daily Prize as detailed in Annexure I.
 - v. **Website/Microsite:** www.oreo.in/dreamfortheteam
 - vi. **Leaderboard:** A ranking system for Participants, accessible on the Website, which displays achievements based on points earned from submitted and fulfilled dreams.
 - vii. **Traditional Trade:** Refers to the unorganized retail sector, typically comprising small, independent, and often family-owned shops such as 'kirana' stores, general stores, or local neighbourhood shops. These include the stores where the packs listed in Attachment I are primarily sold.
 - viii. **Modern Trade:** Refers to the organized retail sector, typically including large-format stores such as supermarkets, hypermarkets, departmental stores, and cash-and-carry outlets, where the packs listed in Attachment II are primarily sold.
 - ix. **E-commerce:** Refers to online retail platforms and websites where products are sold directly to consumers, including but not limited to online grocery stores, marketplaces, and quick commerce platforms, where the packs listed in Attachment II are also available.
 - x. **Personal Information:** Includes, but is not limited to, name, mailing address, date of birth, e-mail, contact number, identity verification document.
 - xi. **Force Majeure Event:** Circumstances beyond the reasonable control of Mondelez and/or Campaign Partner (e.g., floods, natural disasters, war, lockdowns, technical snags).

2. CAMPAIGN PERIOD & GEOGRAPHICAL SCOPE

- i. **Campaign Period:** From 00:00:01 hours on **February 1st, 2026**, to 23:59:59 hours on **March 8th, 2026**. Entries outside this period will not be considered for any prizes.
- ii. **Geographical Scope:** Applicable across India, except in the state of Tamil Nadu due to the Tamil Nadu Prize Schemes Prohibition Act, 1979. Participants from Tamil Nadu may participate but are not eligible to win any prizes.
- iii. **Prize Disbursement:** Commencement of prize disbursement is from 5th Feb, 2026 onwards.

3. ELIGIBILITY CRITERIA

To participate and be eligible for prizes, You must fulfill the following:

- i. Be a natural person.
- ii. Be an individual legal resident and citizen of the Republic of India and not be residing outside the geographical boundaries of India at the time of participation.
- iii. Be 18 years or above at the time of entry.
- iv. Be legally competent to enter into a binding contract under Indian laws.
- v. Hold a valid PAN card issued under the Income-Tax Act, 1961.
- vi. Not be an employee of Mondelez, Campaign Partners, their immediate family members (spouses, domestic partners, parents, grandparents, siblings, children, grandchildren), affiliates, advisors, or advertising/Campaign agencies.
- vii. Participants warrant that they (a) do not have any existing criminal cases or legal prohibitions preventing them from leaving India; (b) have no outstanding dues to government or regulatory bodies; and (c) are not under any legal restriction that would prevent entry into the United Kingdom.

4. HOW TO PARTICIPATE

1. **Purchase Product:** Purchase a limited-edition Oreo "Dream for the Team" pack (refer to Attachment I & II for specific Products). Participation is subject to Product availability. The Participants agree and acknowledge that participation in this Campaign is by virtue of the purchase of these special edition packs, and no separate consideration is payable towards such participation.
2. **Scan QR Code & Register:** Scan the QR code on the pack (or other creative touchpoints like banners) to access the Website. Provide Your Name, Email ID, Date of Birth and Phone Number. By submitting your details, You consent to Mondelez's privacy policy (www.oreo.in/dreamfortheteam).
3. **Login & Dream Registration:**
 - a. Upon logging in, choose an avatar.
 - b. You will receive one digital "Oreo Dream for the Team" cookie for free to start your dreaming journey. While all 16 cookies will be visible, the ones you have not yet scanned will appear as locked. These locked digital cookies can be collected/unlocked by scanning unique QR codes found inside promotional packs.
 - c. To register a dream:
 - i. Choose an available cookie from your digital wallet or scan a new cookie from a promotional pack.

- ii. Select an India vs. other country match from the ICC T-20 World Cup 2026 tournament.
 - iii. Select a pre-defined dream/wish for the chosen match, associated with the selected cookie. You can also use open fields for specific user inputs (e.g., player name, numerical values).
 - iv. Submit your finalized dream.
- b. Dream Tracking: The fulfilment status of your registered dream (whether the anticipated event occurs in the match) will be updated on your user profile.
- i. All the dreams have been categorized into the following three categories and the fulfilment of these dreams will be done on the respective fulfilment criteria:
 1. Dreams which can be fulfilled during the match, such as, “___ player hits 5 sixes”. As soon as the respective player hits the said no of sixes the dram will be qualified as fulfilled immediately.
 2. Dreams which can be fulfilled only after the respective match has been completed, such as, “_____ will hit the highest no of sixes in the match”. This dream can only be considered fulfilled once the match has been concluded and all match data is available for evaluation. These dreams will be highlighted with an “*”.
 3. Dreams which can be fulfilled only after the tournament has been completed, such as, “India will win the tournament”. This dream can only be considered fulfilled once the tournament has been concluded and all tournament data is available for evaluation. These dreams will be highlighted with an “*”.
 - c. Multiple Dreams: You can register any number of dreams with each cookie for any upcoming match. One specific dream can be submitted only once for a particular match but can be used multiple times across different matches.
 - d. Leaderboard: The number of fulfilled dreams impacts your standing on the Leaderboard, which tracks achievements of participants across India (except Tamil Nadu).

5. LEADERBOARD POINTS SYSTEM

Your leaderboard standings will be determined as follows:

- For every dream submitted: **10 points**
- For every dream that comes true: **50 points**

The objective is to achieve the highest number of fulfilled dreams to lead the leaderboard.

6. PRIZE CATEGORIES AND SELECTION

All participants who meet the eligibility criteria and participate between February 1st and March 8th 2026, stand a chance to win. Disbursement of prizes will commence from February 5th, 2026.

Notes on Prizes:

- i. **Leaderboard for Grand Prize & Dreamer of the Match:** These prizes are merit-based on leaderboard performance.
- ii. **Random Draw for Weekly & Daily Prizes:** These prizes are selected via a randomizer tool.
- iii. **Indicative Numbers:** The number of prizes mentioned is indicative and may be modified by Mondelez without prior notice.

7.1. Disqualification: Mondelez reserves the right to exclude or disqualify any person from the Campaign, or forfeit any prize, without liability, if they:

- i. Engage in misconduct, have a criminal record, act dishonestly, fraudulently, or in bad faith.
- ii. Tamper with the entry process or Campaign operation.
- iii. Act in violation of these T&Cs.
- iv. Act in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass others.
- v. Submit entries that are offensive, distasteful, unacceptable, or against Mondelez's ethos.
- vi. Provide incorrect or fraudulent information.
- vii. Fail to provide necessary verification documents within stipulated timelines.
- viii. For any other reason Mondelez deems fit and proper.

7.2. Prize Conditions:

- i. Prizes are non-transferable, non-assignable, non-substitutable and cannot be exchanged for cash.
- ii. In the event of a Prize Winner's death, no nominees, heirs or other persons shall be eligible for the Prize.
- iii. Prizes (including merchandise) are provided "as is" without warranties of any kind (express or implied), including quality, suitability, comfort, merchantability, or fitness for a particular purpose.
- iv. Unless the Prize is a Mondelez or Campaign Partner product, Mondelez and/or Campaign Partner shall not be liable for any defects, deficiencies, damages, replacements, or quality issues related to the Prize. Grievances should be directed to the manufacturer or supplier/retailer/service provider.

7.3. Technical Disclaimers & Campaign Integrity:

Mondelez and/or Campaign Partner will not be responsible for:

- i. SPAM messages, SMS/WhatsApp/other messaging service delivery failures.

- ii. Lost, misdirected, late, incomplete or unintelligible entries, or inaccurate entry information due to technical or human error.
- iii. Printing or typographical errors in Campaign materials.
- iv. Errors in operation or transmission, theft, destruction, loss, unauthorized access to, or alteration of entries.
- v. Technical, network, telephone, computer, hardware or software malfunctions, or traffic congestion on the internet or any website.
- vi. Injury or damage to your computer or mobile device resulting from downloading Campaign materials.
- vii. Inability of participants to use devices/means supporting Campaign technical requirements.
- viii. Participation despite DND registration (by participating, you provide express consent to exempt Mondelez/Campaign Partner from DND restrictions).
- ix. Other conditions beyond reasonable control or any Force Majeure Event.
- x. Any attempt to deliberately damage any Mondelez or Campaign Partner website, interfere with its functioning, or undermine the Campaign's legitimate operation is a violation of criminal and civil laws. Mondelez reserves the right to seek damages to the fullest extent permitted by law.
- xi. The Campaign is subject to all applicable central, State and local laws and regulations in India. The Campaign may at any time at the sole discretion of Mondelez be terminated/cancelled/amended/suspended for any reasons without providing any prior notice to the Participants. No claims/questions shall be entertained in this regard.
- xii. If the Campaign is interfered with (e.g., viruses, bugs, tampering, unauthorized intervention, technical failures) to an extent that it cannot be conducted as planned, Mondelez may, in its sole discretion and to the fullest extent permitted by law, invalidate/disqualify any Participant, or modify, suspend, terminate, or cancel the Campaign.
- xiii. Mondelez and/or Campaign Partner are not liable for any problems or technical malfunctions related to network, servers, lines, computer equipment, software, or mobile networks, including damage to devices.
- xiv. Mondelez and/or Campaign Partner are not responsible if participants are unable to submit entries due to telecom operator issues, internet problems, device incompatibility, or capacity constraints.
- xv. While reasonable efforts will be made to protect participant data, Mondelez and/or Campaign Partner are not responsible for data loss, security breaches, or any actions taken due to such loss.
- xvi. Mondelez and the Campaign Partner are not responsible for the content, privacy policies, or reliability of any third-party platforms, social media networks, or linked websites utilized in this Campaign (including the Microsite and any travel booking platforms). Participation on such platforms is subject to the respective third party's terms of use.

7.4. Indemnity & Liability Release:

By participating, You:

- i. Release Mondelez, Campaign Partner, and their affiliates, employees, directors, representatives, and agents from any and all liability in relation to this Campaign, including including loss or damage caused or contributed to by the negligence of Mondelez or the Campaign Partner, for quality of prizes, personal injuries (including death), property loss or damage, misuse of benefits/prizes etc.

- ii. Agree to indemnify Mondelez, Campaign Partner, and their respective officers/employees from and against all liability, cost, loss or expense arising out of prize acceptance or Campaign participation, including personal injury and property damage, whether direct, indirect, consequential, foreseeable or due to negligence.
- iii. Acknowledge sole responsibility for all taxation arising from winnings/Prizes and shall not hold Mondelez and/or Campaign Partner responsible for payment or related disputes.

The obligations under this Clause shall survive the completion or termination of the Campaign.

7.5. Personal Information & Privacy Policy:

- i. By participating and providing information, You consent to the collection, receipt, possession, use, storage, handling, transfer, processing, sharing and dealing with your Personal Information by Mondelez and Campaign Partner for Campaign purposes.
- ii. You agree to the Privacy Notice of Mondelez posted on the Campaign Website/Microsite.
- iii. Prize Winners may be contacted by the Campaign Partner to collect further details for prize delivery. Prizes will only be provided upon submission of all requested information. Participants are solely responsible for errors in provided information.
- iv. Mondelez reserves the right to refuse prizes if necessary information is not provided. Prize Winner names may be posted on the Website/Microsite.
- v. You authorize Mondelez and/or Campaign Partner to use your shared personal data.
- vi. You consent to Mondelez and/or any nominated third party carrying out profiling of your anonymized data. Campaign Partner will secure and keep safe such information.
- vii. While commercially reasonable means are used to protect your information, no data transmission is 100% secure.
- viii. Your personal Information may be retained and used until the purposes for its use are no longer applicable, or as required by law, regulations, contractual obligations, or legitimate business purposes and used even after the Campaign ends for the purpose of the establishment, exercise or defense of any legal claim or for statutory compliance.

7.6. Intellectual Property & Publicity:

- i. All rights, title, and interest, including intellectual property rights, in all promotional and Campaign-related material (including submitted content) vest solely with Mondelez.
- ii. Mondelez and/or its affiliates have the perpetual, irrevocable, worldwide right to use your name, likeness, images, videos, voice, appearance, and any material provided or taken in relation to the Campaign ("Publicity Material") for any communication, promotions, events, or campaigns, in any medium, without any permission or payment to the Participant.
- iii. You acknowledge complete ownership of your Publicity Material, including copyright, vests with Mondelez, and you release Mondelez and its agents/assigns from any claims connected with such use.
- iv. Mondelez shall have the absolute perpetual, royalty-free, non-exclusive, irrevocable sub-licensable and transferable right to use the winner's likeness, personality/publicity rights, and materials submitted by and/or in relation to the Participant in any media throughout the world without notice, compensation or the winner's right of approval. This includes the right to alter, distort or use the material in composite forms for promotional purposes.

7.7. Force Majeure:

- i. This Campaign is subject to Force Majeure Events. Mondelez and/or Campaign Partner shall not be liable for any delay or adverse effect caused to Participants or Prize Winners due to a Force Majeure Event.
- ii. If due to a Force Majeure Event, a Grand Prize cannot be awarded, alternate prizes (which may not be of similar value or engagement) may be offered by Mondelez.

7.8. Governing Law & Jurisdiction:

- i. These T&Cs are governed and construed in accordance with the laws of the Republic of India.
- ii. The courts of competent jurisdiction at Mumbai shall have sole and exclusive jurisdiction for any disputes arising out of or in connection with the Campaign.
- iii. Participation is unauthorized in any jurisdiction that does not give effect to all provisions of these T&Cs.

7.9. Miscellaneous:

- i. This Campaign is offered on a "best effort" basis.
- ii. Mondelez and Campaign Partner are not liable if Government restrictions (on movement, operations, etc.) impact the Campaign or prize delivery. Participants must comply with all government directions.
- iii. All decisions by Mondelez regarding the Campaign are final and binding. Failure to enforce any T&Cs does not waive them.
- iv. Mondelez is not liable for costs incurred by you for Campaign participation.
- v. Campaign announcements and T&Cs will be posted on the Website/Microsite.
- vi. If dissatisfied with the Campaign, your sole remedy is non-participation.

7.10. Complaints:

- i. For disputes, complaints, or queries pertaining to this Campaign or Products, contact 1800 22 7080 or suggestions@mdlzindia.com no later than 7 working days from the date the cause of the

complaint arose or from the completion of the Campaign, whichever is later. Failure to do so will result in expiry of claims.

- ii. Mondelez holds no liability for complaints/grievances regarding products or prizes provided by Campaign Partners; these should be directed to the respective manufacturer/supplier.

8. WINNER SELECTION & VERIFICATION PROCESS

- i. **Announcement:** Winners will be announced on dates decided by Mondelez/Campaign Partner and contacted by the Campaign Partner via calls, direct messages, WhatsApp or email. By accepting these T&Cs, you consent to being contacted for Campaign purposes.
- ii. **Verification:** Prize Winners must respond to confirm eligibility and provide verification documents **within 3 days of initial contact**. Required documents include:
 - Copy of PAN Card.
 - One of the following (for ID verification): Driving License, AADHAR, Passport, or Voter ID Card.
 - For Grand Prize Winners:
 - a. Valid passport copies for themselves and their companion.
 - b. Mondelez reserves the right to perform a personal background check on potential Grand Prize winners and their companions, including but not limited to a search of criminal records and social media conduct. Participation is conditioned upon Mondelez's satisfaction with the results of such background checks. Mondelez may disqualify any winner if the check reveals any matter that could bring the Brand into disrepute.
- iii. **Disqualification for Non-Compliance:** If documents are invalid, issues are identified, or not provided within 3 days, the Participant will be disqualified. Mondelez/Campaign Partner are not responsible for loss of documents.
- iv. **Contact Attempts:** If a Prize Winner is unreachable or does not respond, two further attempts will be made within the next day. If no response after the third attempt, the participant's entry will not be considered, and the prize may be forfeited or offered to another participant at Mondelez's discretion
- v. Each winner will be contacted three (3) times by or on behalf of Mondelez. In the event a winner is unreachable, remains unresponsive or cannot redeem the Prize for any reason whatsoever, Mondelez reserves the right to either forfeit the Prize or award it to another Participant (chosen via randomizer/leaderboard rank), without further notice or liability to the original winner.

9. GRAND PRIZE SPECIFIC CONDITIONS

- i. **Grand Prize Covers:** The winner will be entitled to receive a digital travel voucher (MakeMyTrip) worth INR 4,00,000/- ("Prize") for utilization by herself/himself and one companion for booking the flight tickets and hotel, along with 2 tickets for the Lord's Classic Tour at the Lord's Cricket Ground, London.

 - The digital travel voucher and tour tickets shall be delivered/made available via the contact details provided during registration. Mondelez/Campaign Partner shall not be liable for loss or non-receipt of the Prize due to incorrect details provided by the Participant. Mondelez and the Campaign Partner accept no responsibility for the reliability, service quality, or privacy practices of the voucher issuer (MakeMyTrip) or any associated travel service providers.
